The proposed improvements are intended to provide a flood protection level up to a 100-year storm event in the local area. The Project improvements would include approximately 4,200 feet of storm drain, 10 catch basins, two infiltration facilities, two diversion structures, one weir structure and energy dissipation, where necessary. The Project would also include a dual-purpose Stormwater Management and Retention Treatment (SMART) basin south of Sunnymead Boulevard. The basin would reduce flows through detention of the peak rate of the 100-year storm, while also providing a low flow retention element to support habitat and preserve beneficial uses through infiltration and recharge of groundwater.
