A. Special Events

Claudia Torres gave information on the Public Safety Expo on May 17. The expo is a free family-friendly event which offers hands-on exhibits, exciting demonstrations, music, food, and giveaways.

B. Community Services

Nikki Hendricks started updates with the Summer Swim Program. The Summer Swim Program will be held at the Valley View High School Pool from June 23 to August 2. Agreements with both Premier Aquatics and the Moreno Valley Unified School District have been finalized. Promotional efforts are underway, and classes are already filling quickly. A Child's Place celebrated a Hop into Spring Event that took place April 14-18, where students were able to participate in an egg hunt, carnival games, and an "Adopt a Peep" activity.

For Recreation in April highlighted Glowing Crazy Teen Egg Hunt in April where over 100 teens also enjoyed, food, games, raffles, and music. Graduates from our Time for Tots program will participate in a graduation ceremony on May 22, at the Conference and Rec Center. A Summer Silent Disco Bash will be hosted at the Teen S.P.O.T. on May 30, where teens will enjoy three genres of music through party headphones, food, and games.

Senior Center April highlights include recognizing Rita Butler by City Council and her receiving the Community Champion Award at the CPRS District 11 Awards and Installations. Virtual Dementia Tour was held on April 11, and 150 seniors participated in the Senior Center Egg Hunt on April 21. May will hold a Cinco de Mayo Event, Casino trip for 57 seniors, Feeding America on May 8, and a Senior Townhall Meeting on May 19.

C. Parks and Landscape Services

Dan began his updates with projects that have been completed which include sports field light bulb replacements and tree trimming at various parks and trails.

Projects underway include addressing weeds at all parks and trails, repairing splash pad at Celebration Park, and the tennis court conversion to six pickleball courts at Woodland Park.

Projects in the planning/design phase include field renovations at Sunnymead, Morrison, Shadow Mountain Parks for the Summer of 2025. Restroom building at Civic Center Amphitheater and restroom renovation at Community Park are additional projects. Lastly, picnic shelter replacements at Gateway Park, Hidden Springs Parks, and playground replacement at Vista Lomas Park and at Pedrorena Park are in planning/design phase.

Projects underway are the site improvements and bike amenities at Flight Deck Bike Park, Senior Center expansion, Grand Valley Ballroom patio lighting, Gateway Park Revitalization Project, Basketball Court at Patriot Park, and Equestrian Center Trail improvements.

D. Administration and Financial Service

Jeanine provided updates starting with CA Parks Habitat Conservation Fund grant will allow for improvements along the Equestrian Park & Nature Center trail that will expand opportunities for a multi-use trail and connect residents to the outdoor setting. Design meeting was on April 15, construction is to begin in June 2025 and is estimated to be completed in December of 2025.

Library's updates include Dia de Los Ninos on April 30, tech on wheels Monday-Wednesday at different locations, and Neighborhood Forest that distributed free trees on April 26, for Earth Day.
