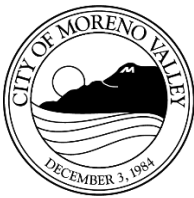

RECOMMENDED ACTION

Staff recommends that the Senior Citizens' Advisory Board (S.C.A.B.) receive and file this program update.

SUMMARY

- Senior Center attendance March 2024: 3,783 averaging 180 per day (February, 3,147)
- Senior Center membership end of March 2024: 3,524
- Meals delivered February 2024: 2,000 meals to 400 seniors, averaging 100 seniors per week.
- Hot lunches served March 2024: 2,016, averaging 96 per day (February 1,785)
- FSA has implemented new take home meals on weekends for seniors. Date T.B.A.
- Feeding America distributed (# not in at time of report) non-perishable food boxes on April 11, 2024, Senior Center continues to lead the I.E., in boxes distributed to seniors.
- The Center operates as a warming center when temperatures drop below 35 degrees.
- The Center's banquet room continues to average two banquet rentals a month and two church rentals every Sunday.
- Healthcare agencies are available at the Center to discuss health care options.
- Friends of Moreno Valley continues its partnership with the Salvation Army to provide 36 seniors with perishable food items. Distribution will be every Friday.
- Friends continues providing free shuttle service to seniors for all medical and grocery needs as well as free coffee.
- Haircuts continue to be full at the senior center every Tuesday. Appointment required.
- Extra translation headsets were purchased and are available for meetings, if needed.
- AARP still doing taxes. Last day April 15
- Contract has been solidified for H & L Charter for casino trips.
